CRIME STATISTICS/CAMPUS SECURITY REPORT

Students and employees a Gupton-Jones College are encouraged to be acutely aware of their own security and that of others around the school facility. Any incident which might appear to be a violation of school rules, or local laws, should be reported to the office of the President, Administrative Assistant, or the Registrar at the College. The College is located in Dekalb County, GA, and the county police authorities are responsible for security and law enforcement in the vicinity of the College. If necessary, the office personnel will contact police authorities to handle matters under their jurisdiction. If a student wishes to contact the police department directly, their local phone number is 404-294-2000.

Information concerning crime prevention, personal security, and rape crisis/sexual offense counseling, is available to students and employees in the College library. Any student or employee desiring such materials will find it prominently displayed in the periodical section of the library. Additional materials may be available from the librarian.

In order to make all students and employees aware of any past criminal activity, the College has noted that from January 1, 2020 until December 31, 2021, the following crimes have occurred on campus:

- 0 Murders 0 Aggravated Assaults

Also, during the 2020 and 2021 calendar years, the following number of arrests for the crimes noted below have occurred on campus:

As is mentioned in the College student handbook, the possession, sale, or use of alcoholic beverages or illegal drugs is absolutely forbidden in or on the College premises. The College will take appropriate disciplinary action, to include suspension, expulsion, or referral to police authorities for prosecution, any individual who violates these standards or breaks relevant laws governing these activities.

Attached is additional information concerning drug abuse policies at the College and the availability of drug and alcohol related counseling.

In addition to the aforementioned policies, the College maintains a strong position against any form of sexual assault, sexual harassment, or other sex-related offenses. As with other criminal activity, it is recommended that any student or employee who is a victim of a sex-related offense to report the offense to the President, Administrative Assistant, or Registrar's office at the College. College authorities will assist in notifying the proper police agency if the victim so desires, or contact may be made directly by the person involved.

In the event of any incidence of alleged sexual offenses, the College will conduct a hearing to determine any disciplinary action which may be taken. Such a hearing would allow both the accused and the accuser an opportunity to present their viewpoints and to have others present during the proceeding. The outcome of any such proceeding would be made known to both parties, and could involve suspension or expulsion from the College, as well as notification of the proper police authority if necessary.
